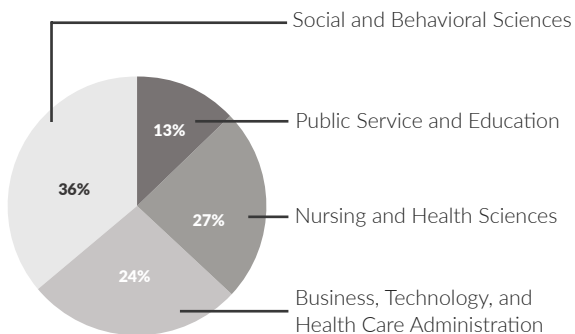

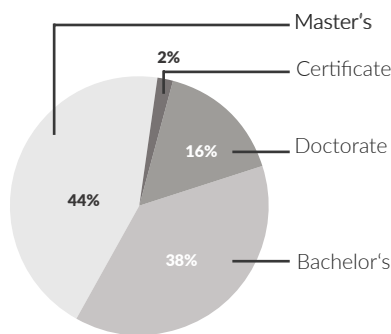
## University Enrollment by School

(Updated annually - as of December 31, 2023)<sup>2</sup>



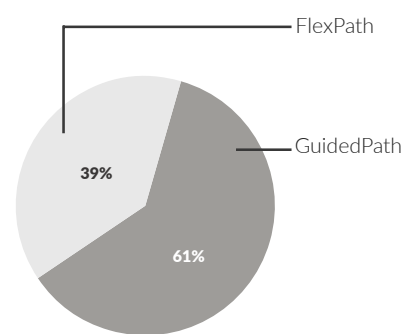
## University Enrollment by Degree and Certificate
